- (C) The scholarship will be paid to the students according to the Govt. rates.
- 3. (A) Students with a break in studies should submit a gap certificate in the form of an affidavit stating the reason for the gap.
 - (B) Students who received Govt. of India scholarship in the previous year and have passed the annual examination, are also required to submit the application form. Their cases will be forwarded to the Divisional Social Welfare Officer, Amravati by the college for the renewal of the scholarship.
- 4. Rajarshi Chhatrapati Shahu Maharaj Shikshan Shulk Shishyavrutti: Those whose parents' income is less than Rs. 2,50,000/- are declared as economically backward. Their fees are reimbursed by the State Government.
