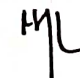



30/0415/C.No.96/F.1 Dt 10/8/2018

Vide the Government of India, Letter cited above in Reference No.1, as per the provisions of Scheduled tribes and other traditional Forest Dwellers Act (Recognition of forest Rights) Act-2006 (2 of 2007) Government of India, have issued guidelines to create, Critical Wild Life habitat, for National parks/sanctuaries in the state.

As per the point No. 5 of the guide lines, it is mentioned that in exercise of the powers conferred by clause (b) of section (2) of the Act the Chief Wild Life Warden of the state Government, on behalf of the central Government shall with the approval of the State Government notify Expert Committees, for the purpose of identification of Critical Wild Life Habitat, in a National Park or Sanctuary As per this provisions the proposals were asked for formation of Committees for every P.A.s from the respective authorities.

In the state of Maharashtra there are 49, Sanctuaries and 6 National parks, total 55, P.A.s out of which 36 proposals for formation committees for 36 P.A.s were obtained, which were submitted to the State Government for approval. Government of Maharashtra approved the proposal of formation of Expert committees vide above reference Letter No. 2

So with the approval by state Government the office is giving sanction to the Expert Committers as following composition, as per the guide lines of Government of India,

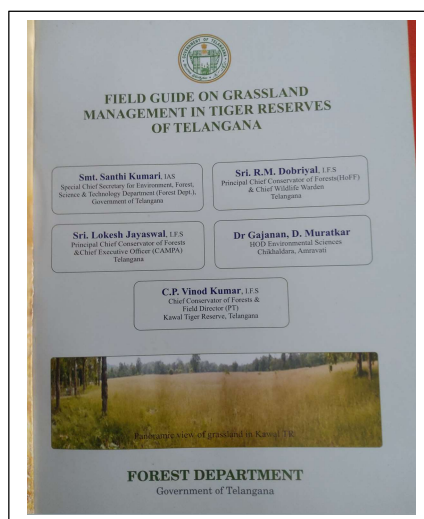
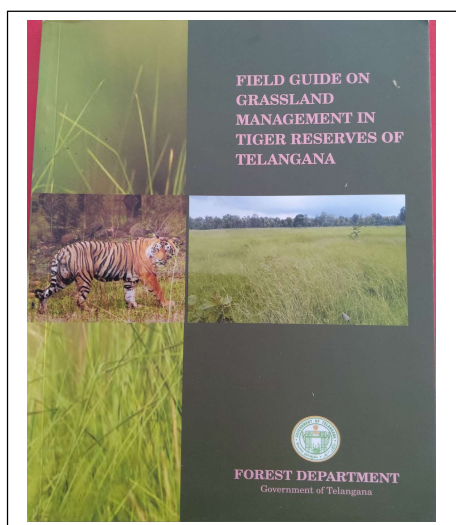


